RECHARGING THE GO

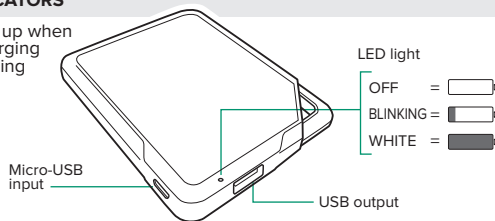
Using the included cable, connect the Micro-USB end into the GO and the other end to any USB power source. Fully charged unit shows a solid, white LED.
