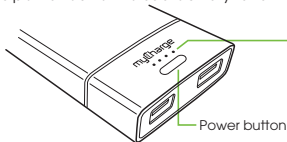
## Recharging **RAPID RECHARGE<sup>MAX</sup>**

## Charging Devices

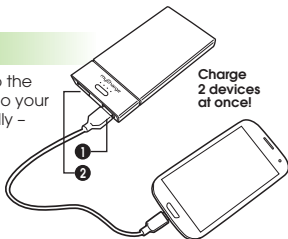
