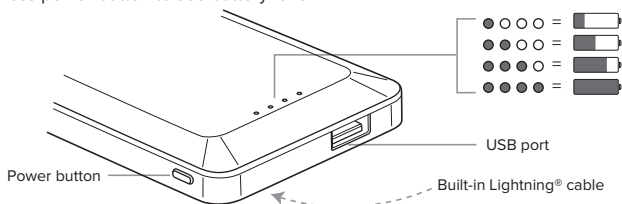
RECHARGING HOME&GO+

Pull out the built-in wall prongs and plug into wall outlet. Fully charged unit shows 4 solid, non-blinking LEDs.



LED INDICATORS

Press power button to see battery level



CHARGING DEVICES



USB Port: Using your own cable, plug the USB end into the HOME&GO+ and the other end into your device. Charging should begin automatically – if it doesn't, press the **power button**.



Lightning Cable: Plug the built-in cable into your device. Charging should begin automatically – if it doesn't, press the **power button**.

You can charge your devices even when HOME&GO+ is recharging.
