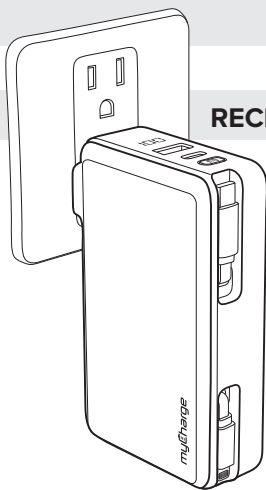

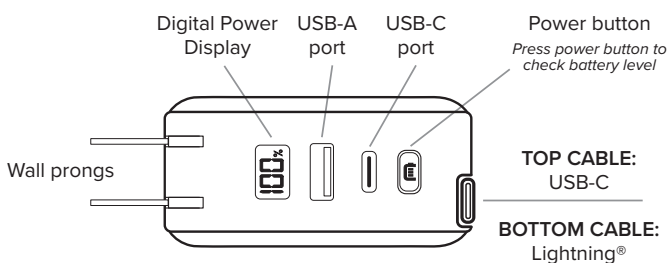
DUAL CABLE PORTABLE CHARGER

Pull out the built-in **USB-C or Lightning®** cable to desired **length** and plug into device. Charging should begin automatically – if it doesn't, press the power button.

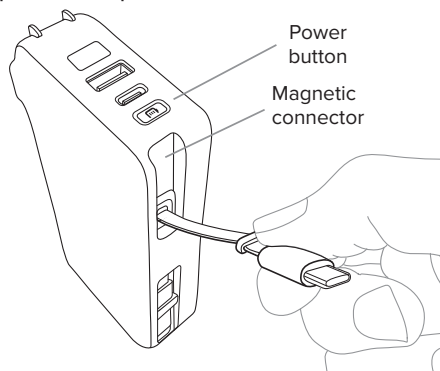
TO USE:

Pull slightly and cable will retract into powerbank.

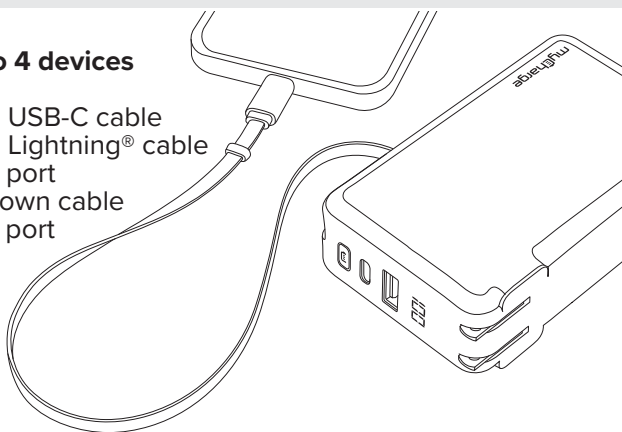
The magnetic connector holds cable in place.
