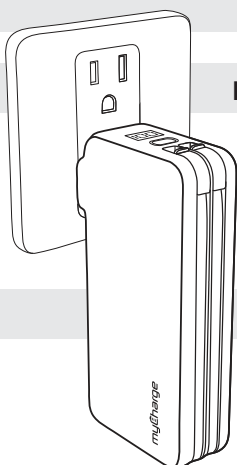

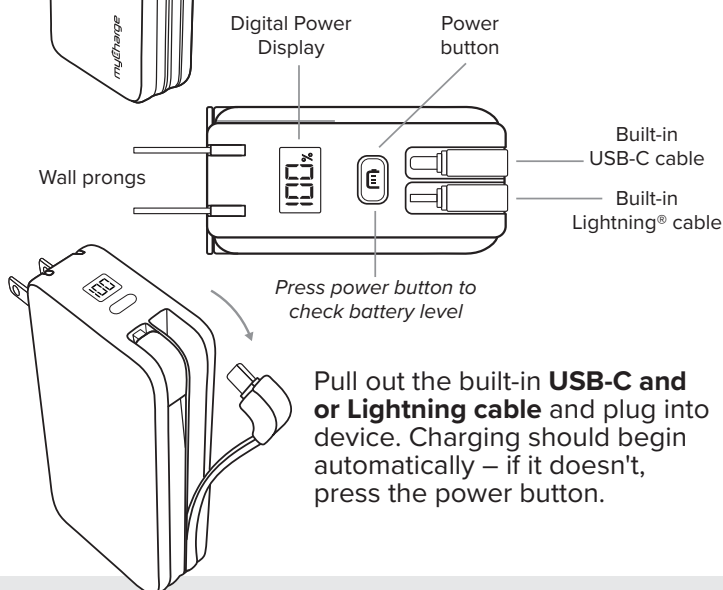
## DUAL CABLE PORTABLE CHARGER

### RECHARGING POWERHUB + 10K



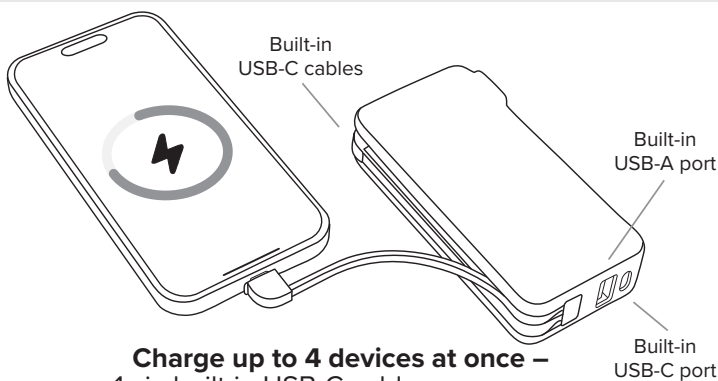
Pull out the built-in wall prongs and plug into wall outlet. Fully charged unit shows 100% in digital display.
