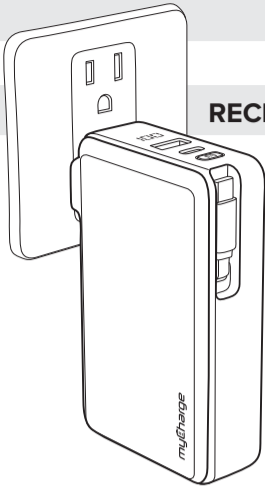

ALL-IN-ONE PORTABLE CHARGER

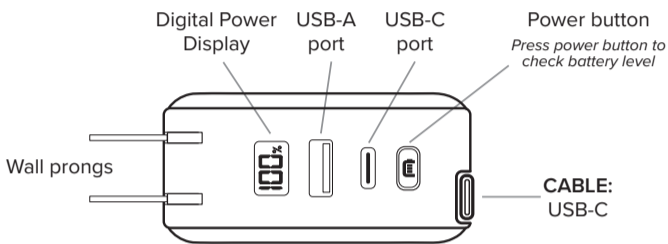


RECHARGING RETRACTACHARGER

Pull out the built-in wall prongs and plug into wall outlet. Fully charged unit shows 100% in digital display.

Recharge time (0–100%) is about 2.5 hours, optimized for efficiency and low heat.

RETRACTABLE CABLE

Pull out the built-in **USB-C cable to desired length** and plug into device. Charging should begin automatically – if it doesn't, press the power button.

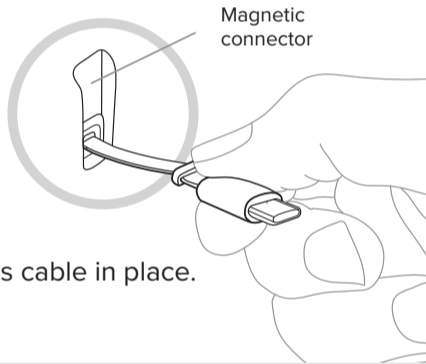
TO USE:

Pull slightly and cable will retract into powerbank.

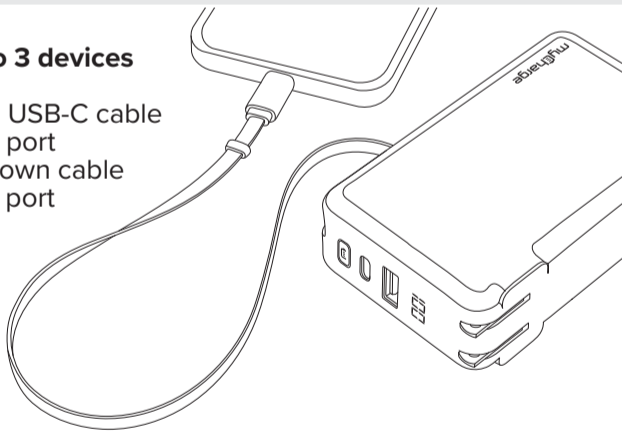
The magnetic connector holds cable in place.
