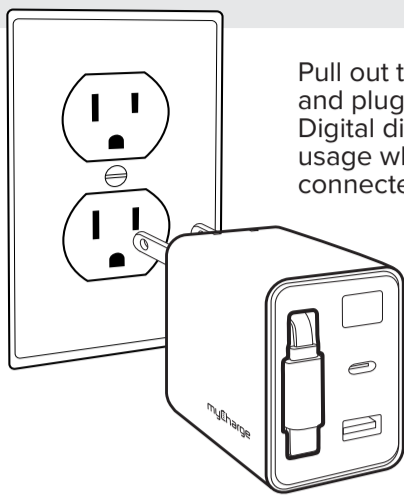
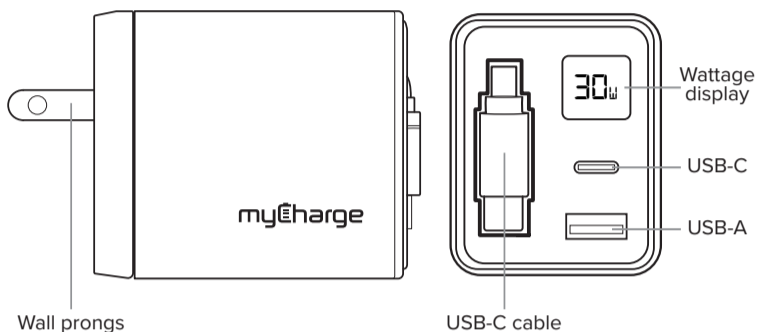


# RetractaPower 30W GaN WALL CHARGER WITH RETRACTABLE CABLE

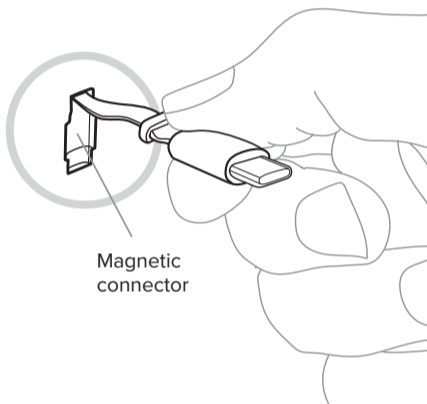


## RETRACTABLE CABLE

Pull slightly and cable will retract into powerbank.

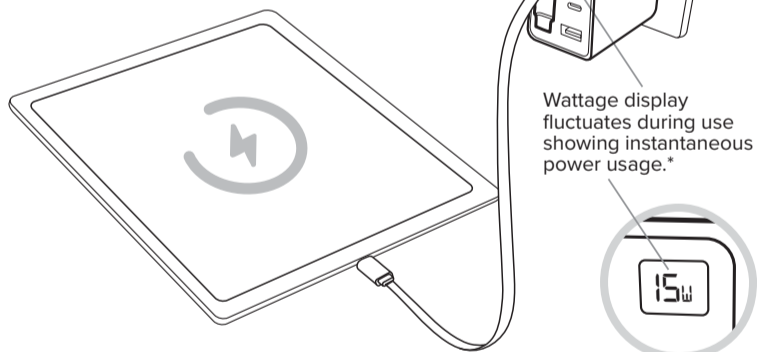
The magnetic connector holds cable in place.
